

Salim G. Sfeir

Chairman, The Association of Banks in Lebanon

Dr. Salim G. Sfeir has been the Chairman of the Board and General Manager of Bank of Beirut since 1993. He is currently the Chairman-CEO of The Bank of Beirut Group. In June 2019, Salim Sfeir was unanimously elected as chairman of the influential Association of Banks in Lebanon." Dr. Sfeir launched his banking career in 1971 with Bank of Nova Scotia, Beirut. He later held the position of Deputy General Manager with Banque de la Méditerranée from 1980 to 1983. In 1983, Dr. Sfeir founded Wedge Bank (M.E.) s.a.l., Beirut, and took on the role of General Manager and Board Member until 1989. In 1987, he was appointed General Manager - Chief Executive Officer at Wedge Bank (Switzerland) S.A. and remained in that position until 1991, after which he was appointed Vice Chairman in January 1992

Gilbert Hobeika joined Fitch Ratings London in September 2015 then relocated to Dubai office in July 2018. He covers banks' ratings in the GCC and Levant in addition to being the lead analyst in Oman, Kuwait, Bahrain and Lebanon. Gilbert Hobeika also covered North Africa (Morocco and Tunisia). Prior to joining Fitch, he worked at Bank of Beirut as a Credit Risk Analyst covering corporates and financial institutions.
